



Important Information Regarding All Competitive Events

Congratulations on advancing on to the 2017 Missouri FBLA-PBL State Leadership Conference! We are delighted to welcome 4,400 Missouri FBLA students to Springfield April 2-4.

Please make note of the following as you prepare for your performance:

1. Before the event

- a. Should your time slot given conflict with another performance you are in (ex. Marcos has Parliamentary Procedure at 12:45pm and Sales Presentation at 1:00pm), please let the State Adviser know so a time slot can be adjusted. Note that some events are close but should not create a conflict.
- b. If you have to drop an event for any reason (illness, family engagement, etc), you must let the State Adviser know at least 24-hours in advance. A \$20 no-show fee will be assessed on each member who does not arrive for their competition.
 - i. Note that for case study/role play events (Banking & Financial Systems, Marketing, Sports & Entertainment, etc) there is a minimum of two (2) competitors. If your team falls below this number when they check in, they will not be permitted to perform and will be dropped from the event.
- c. Ensure that your computer is compatible with our projectors. We will provide both HDMI and VGA connections. Any other adapters are the responsibility of you, including Apple Mac adapters.

2. When you arrive

- a. All competitors must check in at UPH-Illinois 30 minutes prior to their event start time (performance or prep). Once a competitor checks in, they will be held in UPH-Illinois until their assigned time.
- b. A prep room worker or event administrator will come to collect the competitor when their time is ready.
